The products respect global migration limit and specific restriction in the following test conditions:

Simulant Ethanol 50%	(simulant D1)	Duration 10 days Temperature 40 °C

The simulants and the test conditions were chosen referring to the Regulation (EU) No. 10/2011 and subsequent updates and modifications.
